TOP 5 TIPS FOR PATROLLING DURING COVID-19

1. Your safety first. Take a moment to put on your PPE before approaching your patient.

- 2. Carry your PPE on your person, keep extra PPE in your pack and check your stock before patrolling.
- **3.** Sanitize your hands before and after removing your protective gloves.
- **4**. Get a flu shot.
- **5.** Stay home if you are sick.

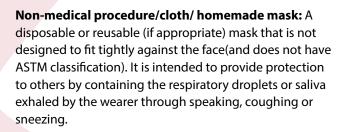
MASK ASTM STANDARD

There are three ASTM classifications for personal protection equipment (PPE) offering varying levels of protection from airborne pathogens. Patrollers should conduct a hazard assessment to evaluate the type of controls recommended for emergency situations including under what conditions which ASTM classification of PPE should be used.



N95 Disposable Respirator: Class 1 medical device used in the protection from procedures that might cause large respiratory droplets containing COVID-19 to be aerosolized into tiny airborne particles such as during aerosol generating medical procedures. Respirators must be regularly fit tested by an authorized tester to the wearer's face.

Surgical/ procedure mask: Class 1 medical device not designed to fit tightly against the face. This type PPE provides a barrier protection against large-particle droplets exhaled from breathing, singing, sneezing, coughing, or bodily fluid, such as saliva. Medical masks should be kept for health care workers providing direct care to COVID-19 patients, and people who are immuno-compromised.
